The prime objective of the Lok Adalats is to settle the disputes amicably through compromise so as to save the time and money of the parties and to reduce personal enmity, between them. Except non compoundable Criminal Cases, all kinds of Cases even at pre-litigative stage can be brought before the Lok Adalat for amicable settlement. Monthly Lok Adalat is being held in all the Judicial Courts in the State of Punjab on the last working Saturday of every Month.

HOW TO FILE THE CASE BEFORE LOK ADALAT?

Every litigant willing for settlement through Lok Adalat can request the Presiding Officer of the Court where his/her case is pending or in case of prelitigative matters, request can be made to Secretary, District Legal Services Authority.

BENEFITS OF LOK ADALAT

- Speedy disposal of cases.
- Award of Lok Adalat is deemed to be the decree of the Civil Court.
- No appeal lies against the Award of Lok Adalat.
- Decisions are taken through compromise.
- Refund of entire Court fee is made.
- Decisions are final in nature.

PERMANENT LOK ADALAT (PUBLIC UTILITY SERVICES)

WHICH ARE PUBLIC UTILITY SERVICES?

- * Transport services for the carriage of passengers or goods by Air, Road or Water;
- * Postal, Telegraph or Telephone Service;
- * Supply of Power, Light or Water to the Public by any Establishment;
- * System of Public Conservancy or Sanitation;
- **★** Service in Hospital or Dispensary;
- * Insurance Services;
- * Banking, Housing & Finance Services;
- Imparting education or its connected matters;
- * Immigration Services or its connected matters;
- * New connections of LPG and supply of LPG or refills or its connected matters;
- * Aadhar Card, Ration Card, Voter Identity Card and Below Poverty Line (B.P.L.) Card;
- ★ Old Age and Widow Pension;
- * Shagun Scheme and Unemployment Allowance;
- * Public Distribution System Services;
- * Services relating to the registration of Births and Death;*
- * Services relating to the registration of Marriage; * and
- * Services relating to the registration of Vehicles/issuance of Driving License under the provisions of Motor Vehicles Act.*

HOW TO FILE CASE IN PERMANENT LOK ADALAT (P.U.S.)

Cases relating to Public Utility Services can be filed through an application on plain paper before the Chairman, Permanent Lok Adalat for Public Utility Services. The pecuniary jurisdiction of the Permanent Lok Adalat is Rupees One Crore.

- ★ Speedy disposal of Cases.
- * No Court fee is required in filing the Case.
- * Award of Permanent Lok Adalat is deemed to be the decree of the Civil Court.
- * No appeal can be filed against the Award of Permanent Lok Adalat.
