

TENDER NOTICE

Sealed quotations are invited from the authorized Dismantler/Recycler of E-waste who are empanelled with Punjab State Pollution Control Board, for disposal of old/obsolete/unserviceable computer hardware items i.e. Desktops, Monitors, UPS, Printers etc. The details of E-waste hardware, are as under:-

Terms & Conditions:-

1. The successful bidder shall be required to lift all e-waste—old/obsolete/unserviceable computer hardware and not selectively from the designated place to their premises on “AS IS WHERE IS BASIS” within two working days after depositing the full amount.
2. The successful bidder shall be bound to dispose of the e-waste items as per e-waste (Management) Rules 2022.
3. The participants would be required to submit an undertaking to the effect that their firm/company/business entity has not ever been blacklisted by any Government Department/Autonomous Organization etc. or prosecuted by any court of law.
4. The successful bidder will have to pay the entire quoted/offered amount in the form of Bank Draft/Pay Order drawn in favour of Punjab State Legal Services Authority payable at SAS Nagar within two working days from date of opening of tender document failing which his offer shall be deemed to be cancelled and award of the contract will be given to the bidder who have quoted the second highest bid price.

5. The successful bidder on deposit of full amount shall lift the requisite articles from the premises of the State Authority on the same day.
6. All the charges relating to loading/unloading, transportation and other miscellaneous expenses relating to the transportation shall be borne by successful bidder.
7. The quoted price should be inclusive of all taxes/charges.
8. The bidder is required to submit below mentioned documents in a sealed envelope bearing title "Quotation for disposal of E-waste" addressing to **"Member Secretary, Punjab State Legal Services Authority, Sector 69, SAS Nagar"**:-
 - a) Authorization letter from the concerned Punjab State Pollution Control Board
 - b) Undertaking to the effect that the firm is not blacklisted
 - c) Consent Letter in shape of agreement that the terms & conditions of the tender document are acceptable to the bidder
 - d) Quotation Price (inclusive of all applicable taxes/charges/duties).
9. The interested firm/bidder before taking participation may visit the office of State Authority office on any working day between 10:00 AM to 04:00 PM to inspect the hardware items physically.
10. The important dates to complete the entire procedure are as under:-

- The tender documents shall only be accepted by hand or by registered post. The registered post should also reach the office of the State Authority on or before 15.01.2024 till 05:00 PM. The application so received later than 15.01.2024 after 05:00 PM will not be accepted.

- All the participants are required to come present in the office of State Authority on the date of opening of tender document either in person or through their representative.
