## **ANNEXURE B**

### **TERMS & CONDITIONS FOR FLOATING THE TENDER.**

- The Bidders who desires to participate in the auction of the articles (List enclosed) are required to submit the application along with the ID proof to the office of State Authority. The application be submitted on Letter head, in case the bidder is an authorized firm or entity;
- The difference between each bid must be higher than former bid with a difference of minimum Rs. 100/- or its higher multiple;
- The Bidders participating in the auction will have to deposit the earnest money fixed at Rs.3500/- (refundable/adjustable) in cash/DD at the time of auction. Only those bidders who have deposited the earnest money would be allowed to participate in the auction;
- The bidder shall be at liberty to remain present in the auction in person or through authorized representative. In case authorized representatives come present, they must produce the authority letter from the bidder, on whose behalf they are representing, failing which they will not be allowed to participate in the auction;
- The person/dealer/firm with highest bid will have to submit the full payment of the articles (list enclosed) on the spot and require to lift the purchased items on the same day before 05:00 pm. After the payment, this State Authority would not be responsible regarding custody of any of the item;
- The State Authority reserves the right to accept or reject any or all the bids without assigning any reason thereof;
- Any bidder found to be in violation/manipulation of aforementioned terms & conditions will be disqualified on the spot and would be ask to leave the auction venue immediately;
- The State Authority reserves the right to change the terms & conditions as the case may be;
- The conditional offers/tenders shall be out-rightly rejected;
