Deficiency No.2: (Category Column unfilled) Category Column not filled in the Application Form. The information regarding appropriate Category (General, BC, Ex-Serviceman) be provided in writing alongwith demand draft of requisite fee if not deposited.

Deficiency No. 3: (Category written in the Application Form as SC or OBC) As there is no vacancy of SC or OBC Category, therefore, in case, the candidates of SC or OBC Category wants to be treated in General Category, they have to submit the written consent as given in Annexure A, to the effect that they will not claim any benefit under SC category during the service and also have to pay the requisite fee, if not deposited, through Demand Draft in favour of Member Secretary, Punjab Legal Services Authority, SAS Nagar.

Deficiency No.4: (Application Form not attached) Application Form not found attached. Application Form duly filled be produced on or before the test.
